## **UNITINGSA HOUSING CHANGES DUE TO COVID-19**

Dear valued tenant,

In light of the growing number of COVID-19 cases and the Premier of South Australia's announced six-day lockdown in our state, we are temporarily changing the way we deliver our services.

To ensure we can continue providing support while reducing the risk of COVID-19, from today we are:

- **Closing the UnitingSA Housing office** In line with the State Government's lockdown requirements, our office will close for six days and then be reviewed.
- **Cancelling face-to-face contact** In-person meetings will be on hold but the UnitingSA Housing team will still be offering support via phone and email.
- **Putting an immediate halt on 'non-essential' maintenance works** Only emergency maintenance will be carried out on UnitingSA Housing properties at this time.
- Putting processes in place to support postal and email correspondence Tenants are requested to return any formal documentation, such as lease agreements and rent review papers, by mail or email. Self-addressed envelopes will be enclosed with all mail correspondence that we send.

We understand this is a challenging time for everyone and will continue to work to provide you support when you need it. We also encourage you to reach out to your other support services, as required, and remember the SA COVID-19 Mental Health Support line on 1800 632 753.

In addition, there is a growing list of COVID-19 hotspots in South Australia and it is important you are aware of these locations and that you notify us immediately if you have visited any of them at the specified times.

We hope the COVID-19 situation in South Australia is quickly brought under control and we are soon in a position to resume our normal operations.
